HOW TO IDENTIFY POSSIBLE INFLUENCERS/ UNAUTHORIZED FILM CREWS WHO ARE BEING DISRUPTIVE

"a person or group that has the ability to influence the behaviour or opinions of others"

- Cambridge Dictionary

Equipment

One or more members of the group is filming the antics of other members of the group with cameras, phones, microphones, and/or other technical equipment.

Groups

The disruption is caused by a group of individuals working together.

Members of the group make loud announcements or declarations unrelated to the subject matter of the class.

Props

The group brings in props and/or members arrive in costume.

STEPS TO FOLLOW



RECOGNIZE

Assess the situation for safety concerns Remove yourself from the situation if your health and safety is at risk.

POTENTIAL DISRUPTIVE SCENARIOS

SCENARIO 1

Students are in the middle of taking a midterm when a group of influencers suddenly barge into the room. They begin playing loud music, dancing at the front of the classroom, and recording with the cameras.

The disruption interrupts the students' focus on the midterm. They assess the situation around and notice other students are also distracted. The Students avoid engaging with the influencers. The professor asks the students to help document the situation. The Students can self-refer to Case Management Services

SCENARIO 2

Student gets stopped on Bruinwalk by film crew who begin to try bombarding her with questions without her consenting to being filmed or interviewed.



The Student does not want to be recorded. She tells the influencers to stop recording her. The influencers continue asking her questions. The Student walks away as the influencers try to follow her. The Student warns the influencers that she will call UCPD. The influencers back off and leave the student alone. The Student takes a picture of the students with her phone. She locates BIT's website and reports the incident, attaching the documented photo of the influencers as evidence.

SCENARIO 3

Student employee is working when a group of influencers invade their workspace and start breaking and damaging property.

The Student assesses the situation and recognizes that they may be in harm's way. They remove themselves from their workstation to gain distance from the influencers. The Student contacts their direct Supervisor and relays the situation. The Student doesn't feel safe approaching the influencers so they do not return to their workstation. They wait for their direct Supervisor to arrive and resolve the incident. The Student locates BIT's website and reports the incident. The Student self-refers to campus support resources.
